### **TERMS OF USE**

16 December 2024

The following terms ("**Terms of Use**" or "**Terms**") describe the terms and conditions governing your access to and use of the Superscore website and/ or mobile app ("**Superscore**") made available by Sportening B.V., a limited liability company whose registered office is at Jacob Van Lennepkade 155 H, 1054ZL Amsterdam, company registration no. 80209696 (the "**Company**", "**We**", "**Us**").

We do not provide any gambling services through Superscore, and you are not able to place bets while using Superscore.

Superscore is available in both web and mobile version. Depending on the jurisdiction you access Superscore, you might be required to create a user account in accordance with these Terms of Use. Where Superscore website or mobile application is available without registration, these Terms of Use will be applicable without excluding any other laws applicable in your jurisdiction which do not exclude these Terms of Use.

- 1.3 Additional terms may also be posted in specific areas of Superscore, and such terms will govern your access to and/or use of Superscore as if they are incorporated into these Terms of Use.

# II. SUPERSCORE SERVICES AND LICENSE

- **2.1** You acknowledge and agree that We may provide some or all elements of Superscore through third party service providers.
- **2.2** We are constantly in search for ways to improve the quality of Superscore, and for this purpose technical configurations, applications, features, functionalities, infrastructure, security etc. related to Superscore may suffer changes or be updated from time to time. These changes may be made without prior notice to you. If you do not agree to these changes, you must stop using Superscore.
- **2.3** We do not provide any gambling services through Superscore, and you are not able to place a bet through Superscore.
- **2.4** Through Superscore, you may be able to:
  - see the results and statistics of different sports leagues;
  - access information from the world of sports;
  - enjoy other features as made available to you by Us through Superscore.
- **2.5** Subject to these Terms of Use, We grant you a limited, non-exclusive, non-transferable, non-sub-licensable, and revocable license for your personal and non-commercial use of Superscore on any compatible device that you own or control ("License").
- **2.6** Subject to these Terms of Use, the License granted to you does not allow you to sub-license, copy, modify, distribute, duplicate, sell, lease or transfer in any way all or any portion of Superscore.
- **2.7** By using Superscore We may display your username, profile picture, and any information about your actions or relationships with other users of Superscore next to or in connection with accounts, ads, offers, and any sponsored content that you follow, without any compensation to you.

### III. SUPERSCORE ACCESS AND USE

- **3.1** In order to access and use Superscore with all features, you must sign up with Superscore and register an account in accordance with these Terms of Use. You can register for our Services using your social login credentials (Google, Facebook, Apple ID).
- **3.2** You may also access and use certain limited features and functionalities of Superscore without having an Account. In such case, you acknowledge and agree that these Terms of Use are also governing your access to and/or use of Superscore.
- **3.3** You agree that you are solely responsible for all aspects involved by your usage of Superscore and for keeping your username, account information and other personal data you might share confidential.

We shall not be liable to You or to any other third party for failure to offer to you Superscore or its content in connection with any force majeure event, including, but not limited to, electrical, telecommunications, hardware, software or other utility failures, software bugs or weaknesses, earthquakes, storms, floods, fire or other nature-related events, embargoes, riots, acts or orders of government, acts of terrorism or war, technological change, changes in interest rates or other monetary conditions, pandemics and epidemics. # IX. GOVERNING LAW AND DISPUTE RESOLUTION

- **9.1** These Terms will be governed by and construed and enforced in accordance with the laws of the Netherlands, without regard to conflict of law rules or principles that would cause the application of the laws of any other jurisdiction.
- **9.2** You and the Company shall cooperate in good faith to resolve any dispute arising out of or in connection with these Terms of Use, including any question regarding their existence, validity, interpretation, breach or termination, and any non-contractual obligation or other matter arising out of or in connection with them ("**Disputes**"). If you and the Company are unable to resolve a Dispute within 60 days of notice of such Dispute, the jurisdiction and venue for actions shall be the competent courts located in Amsterdam and you and the Company hereby submit to the personal jurisdiction of such courts.

# X. TERMINATION

**10.1** These Terms enter into force on the date you access and/or use Superscore and, unless otherwise stated in these Terms, and the Terms and/or the License are effective until either the date you stop using Superscore or you fail to comply with

any term of these Terms or the date the Company terminates the License, whichever is earliest.

- **10.2** We reserve the right to modify, suspend, or discontinue at any time, without notice, Superscore, including but not limited to Superscore's features and functional elements and related services.
- **10.3** Upon termination, you shall immediately cease any and all access to and/or use of Superscore and to the extent not prohibited by applicable law, all of your rights under these Terms of Use immediately terminate.
- 10.4 To the maximum extent permitted under applicable law, Section IV (USER REPRESENTATIONS AND WARRANTIES), Section V (DISCLAIMER OF WARRANTIES AND LIMITATION OF LIABILITY), Section VI (INDEMNIFICATION), Section IX (GOVERNING LAW AND DISPUTE RESOLUTION), Section X (TERMINATION), shall continue to apply in accordance with their terms.
